Judo Saskatchewan Selection/Funding Criteria for Kata

Basic Criteria

Athletes wishing to travel with the Judo Saskatchewan Provincial Team and wish to receive funding must meet certain basic criteria as follows:

- Must be registered with Judo Saskatchewan
- Must train regularly at the club level
- Must attend provincial kata competitions
- Must attend provincial Kata clinics
- Must have a good judo relationship with their club coach and with the Kata Committee.
- Must sign an Athlete Code of Conduct (along with parent signature if athlete is under the age of 18)
- Must be committed to the Judo Saskatchewan Kata program.

Points Grid

The result is calculated based on total points earned from results in their age group at the following events with a minimum of three entries and one win. There are no points for a last place finish.

Event	Level	1st	2nd	3rd	4 th
Nationals	JC Point	200	175	150	125
Pacific International	JC Point	150	125	100	75
Edmonton International	JC Point	150	125	100	75
Saskatchewan Open	JC Point	150	125	100	75
Manitoba Open	JC Point	150	125	100	75
Provincial Competitions	Provincial	100	75	50	25

If there are no entries for a Kata Team in their age division to compete with at Provincial Competitions, the Kata Committee may award full or partial points if the team attends and participates in some way.

Once the basic criteria are met, participation points will be awarded as follows.

Interprovincial Kata Clinics	120
Continue to train through the summer months.	60
Provincial Kata Clinics	60

Note: In order to qualify for points, a kata team must have demonstrated the ability to win medals in province and place out of province.

Qualifying Period

The qualifying period to earn points shall be one calendar year prior to the event being selected for.

Selections

All selections will be made by the Kata Committee. The first consideration will be Kata Teams having met the basic criteria and the second consideration will be the kata team's placement on the points total. The Kata Committee has the right to consider other factors and may add or remove a team based on their performance, commitment and potential.

Funding

The budget will determine the amount of funding available to be provided to each team. The available funding will be distributed based on the points level achieved by each athlete/team. Teams who are selected but no funding is available may be approved to attend and pay the full athlete cost.

The per cent breakdown will be as follows:

- #1 placing gets 30% of the available funding
- #2 placing gets 30% of the available funding
- #3 placing gets 20% of the available funding
- #4 placing gets 10% of the available funding
- #5 placing gets 10% of the available funding
- #6 placing and beyond are self funded.

Appeals Process

An appeal regarding team selection may be filed in accordance with the Judo Saskatchewan appeal process.
